Delivery fee is included within 25 miles of event location, unless otherwise stated. Client will inform of any adverse conditions that may hinder the delivery and affect the quality of finished balloon decor. After satisfactory delivery and set up by For the Love of Balloons, Client assumes full responsibility for the condition balloon decor.

Outdoor Delivery Disclaimer: Client understands that For the Love of Balloons is not responsible for the condition of products following outdoor setup. Due to the effects of outdoor weather conditions, wind blowing undesirable atmospheric items (e.g., dirt, leaves, or branches), sunlight, insects and other wildlife, it is understood that balloon decor may not hold up and cannot be insured past satisfactory delivery and setup.

### **Damages and Accidents:**

For the Love of Balloons is not responsible for any damages to the balloon decor caused by a guest, employee, or any other person not employed by For the Love of Balloons.

Client assumes full responsibility for the event guests and agrees to indemnify and hold For the Love of Balloons harmless from and against all bodily injury, property damage or consequential damages.

We are not responsible for accidents or injuries related to our decor. Please do not allow guests to put the latex balloons into their mouths. Be aware that some children and adults have allergic reactions to latex.

### **Photography:**

For the Love of Balloons reserves the right to use any photographs of the finished balloon decor for promotion without compensation on Websites and Social Media.

### **Client Responsibility:**

All rental items must be returned within one (1) week from the event. A \$25 late fee will be assessed for each day late and a \$100 replacement fee will be charged should any parts be damaged or not returned if applicable.

### **Creative Control:**

The inspiration and ideas by the Client are presented as representations of the balloon artist. The actual product may vary based on the designer's creative interpretation or structural necessity of the balloon decor, while maintaining the integrity of the overall look of the balloon decor.

DISCLAIMER: By paying for this balloon decor you agree that certain creative changes may be made to your final design for the sake of stability, structural integrity or other certain emergencies. By paying for this balloon decor it is an act of signing this contract that is legal and binding to the fullest extent of the law.

## **Agreement/Jurisdiction:**

This Wedding Cake Contract (the "Agreement") is entered into by For the Love of Balloons located and (the "Client", "You", "Your"). For the Love of Balloons to be referred as to "Artist", "We" "Our". The client agrees to pay For the Love of Balloons for the production and delivery of balloon decor. The following terms and conditions apply:

## **Services/Package:**

- Consultation
- Balloon Set up
- Balloons needed for decor

All extra services are extra and must be paid individually.

## **Communication:**

Clients must provide a minimum of three (3) weeks' notice prior to their event to allow adequate time for preparation and procurement of necessary supplies. Additionally, clients are required to respond in a timely manner, complete all contractual requirements, and submit the required deposit before this three-week deadline. Failure to do so may result in the cancellation of services. Inquiries from clients who do not respond promptly or fail to meet these requirements may not be accommodated.

## **Balloon Consultation:**

An initial balloon consultation either in person/online over email, text, or Instagram to discuss size, design, colors, special requirements, etc. is required for all balloon orders.

## **Equipment Rental:**

If your balloon decor requires equipment such as columns, frames or stands, must be included in the initial non refundable deposit. All rented equipment must be given back in the same condition as it was given within 48 hours unless otherwise discussed.

## **Changes To Design:**

For the Love of Balloons understands that after our initial meeting, the number of balloons and equipment needed or the design desired may change. You may make changes in the size up to 2 weeks before the event date. After these points, both the design and size is set.

## **Payments and Cancellation Policy:**

A nonrefundable deposit is required to place a balloon order and secure a delivery and set up date. The remaining balance is due at the time of the delivery and set up date. Any changes to the order are subject to availability, and may incur additional charges.

Payment can be made via Venmo, Facebook Messenger, Paypal or cash.

For cancellations within one week prior to the event, the entire amount of contract is still owed to For the Love of Balloons

## Outdoor Decor:

We use only the highest quality products to build your balloon decor. However, due to the general nature of balloons, we cannot guarantee that they will stay perfect and intact when used outdoors.

## Extra Fees:

Costs incurred for travel for large balloon pieces in which a U-haul must be rented. All other small pieces included in original price.

## Delays:

The Artist and all decorating staff will arrive onsite as specified by the Client. We cannot be held responsible for delays (or incomplete decor) if not allowed a responsible amount of time to complete decor services as described in this agreement.

## Decor Equipment:

All re-usable non balloon equipment, including but not limited to frame, lighting, poles, fabric, etc. The Client is responsible for all losses due to theft, vandalism, misplacement or damage. In the event that the Artists equipment is damaged, misplaced, or stolen, the client agrees to be billed for the repair or replacement cost of the item(s).

## Material Guarantee :

All materials are guaranteed to be as specified by the manufacturer. If supplier discontinues a product or a manufacturer changes its material type.

*100% (one hundred percent) of the payments paid are forfeited if this Balloon Artist Contract is broken, cancelled or terminated prior to and including the noted wedding date.*
